ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to Ochhe Lal Surya Prasad Mahila Mahavidyalaya, Plot/Khasara No.-543, Street/Road-kotwali Road, Vill-Akbarpur, Post office-Akbarpur, Tehsil-Akbarpur, Distt.-Kanpur Dehat, Pin-209101 vide Order No. NRC/NCTE/NRCAPP-3407/225th Meeting/2013/73657-663 dated 04.03.2014 for B.Ed. Course of one year duration with an annual intake of 100 seats. In light of NCTE Regulations, 2014 revised recognition order No. NRC/NCTE/NRCAPP-3407/2015/102490-95 dated 22.05.2015 for B.Ed. course of two years duration with an annual intake of two units of 50 student each was issued to the institution with following conditions.

AND WHEREAS, the institution has submitted its reply vide letter dated 10.06.2016 and 01.09,2017 received in NRC office on 13.06.2016 and 11.09.2017, the same were considered by NRC in its 308th Meeting held on 25th to 27th September, 2019 and it was decided that Show Cause Notice under section 17 of NCTE Act, 1993 be issued to the institution before withdrawal the said recognition on the following grounds: -

 The Institution has appointed one principal and seven faculty for two units of B.Ed. course which are not sufficient as per NCTE Regulations 2014. The detail of their qualification is also not given.

Accordingly, Show Cause Notice U/S 17 (Complaint) was forwarded letter to the institution on 15.10.2019.

AND WHEREAS, the institution has submitted reply in NRC office on 21.10.2019 & 11.11.2019. The matter was placed before the NRC in its 313th (Part-2) Meeting held from 25th to 27th February, 2020 and the Committee decided that the request of the institution recognition of one unit of B.Ed. course be withdrawn under section of 17 of the NCTE, 1993.

NOW THEREFORE, the Northern Regional Committee hereby withdrawn recognition of one unit (50 seat) from two units (100 seats) of B.Ed. course under section 17 of NCTE Act, 1993 from the end of the academic session next following the date of order of withdrawal.
